POWER OF ATTORNEY No. 696

The Federal State Budgetary Educational Institution of Higher Education "Pacific State Medical University" of the Ministry of Health of the Russian Federation (FSBEI HE PSMU of the Ministry of Health of Russia), located at the address 690002, Russian Federation, Vladivostok, Ostryakova Ave., 2, represented by Acting Rector Vladimir Vyacheslavovich Kuznetsov, acting on the basis of the order of the Ministry of Health of the Russian Federation dated 24.11.2025 No. 298 pk, hereinafter referred to as the "University", taking into account the current Cooperation Agreement with the agency dated 09.02.2026 No. 3/2026, by this power of attorney authorizes the Company "Global Connect Education", (271835, Republic of India, Uttar Pradesh, Shravasti, PO Vijapur Shisawan, House No. 49), represented by Abhinav Kumar Dubey, acting on the basis of the Charter, hereinafter referred to as the "Agent":

- to ensure the selection of candidates from the Republic of India wishing to study at the University on a contractual basis, in the number determined by the University and the Agent;
- to explain to the candidates the conditions and rules for admission, study, and accommodation at the University, as well as to familiarize them with the norms of the legislation of the Russian Federation concerning the rules of stay for foreign citizens in the territory of Russia;
- to collect from the candidates all documents necessary for admission to the University, as provided for by the admission rules for foreign citizens, and to transfer them to the University for consideration by the admissions committee;
- to place at its own expense reliable information about the University, using the information provided by the University, and advertisements for recruitment in the media and

social networks of the Republic of India, and to distribute it by other means not contradicting the legislation of the Republic of India;

– to assist in organizing foreign trips for University employees to advertise educational services, hold meetings and negotiations in Embassies, government authorities, cultural centers, educational and other institutions;

– to ensure that candidates undergo medical examinations in accordance with the requirements of Russian legislation;

– to facilitate candidates and students obtaining, in the established manner, entry and exit visas for traveling to study in Russia and leaving it;

– to ensure the organized dispatch of candidates to the Russian Federation and to inform the University in advance of their arrival;

– based on the lists of candidates enrolled for studies provided by the University, to arrange for the payment of their tuition.

The authorized party carries out its activities within the framework of the legislation of the Republic of India and the Russian Federation.

This power of attorney is issued for a term until 31.12.2026, without the right of substitution to another person.
